AUCTION NOTICE

The Menjong Sorig Pharmaceuticals Corporation Limited (MSPCL) announces the sale of both usable and unserviceable items including vehicle spare parts through public auction at MSPCL premises, Kawangjangsa through sealed bid quotation on 25th December 2023 in the MSPCL Conference Hall at 2:30 PM. The bidders are requested to inspect the items prior to bidding from 11th December 2023 from 9:00 AM onwards. The auction will be on “as is where is basis” status.

Terms and Conditions

1. Each bidder will have to deposit an earnest money of **Nu. 10,000** (Ngultrum Ten Thousand) in the form of cash/cheque along with the bid on or before 25th December 2023 at 2:30 PM to qualify for the auction.
2. No bidder will be allowed to retract the bid(s) after acceptance. All sales are final and binding.
3. The highest bidder, whose bid(s) are accepted, will have to deposit 25% of the auctioned value at the time of acceptance of the bid or the next working day.
4. The balance 75% of the bided amount shall have to be deposited within 10 working days from the day of the auction failing which the accepted bid will be cancelled and earnest money shall be forfeited.
5. The earnest money of the successful bidder will be retained until the auction is completed as a security deposit for the subsequent bid to be offered by the bidder in respect of the remaining items.
6. Earnest money of the unsuccessful bidder will be refunded immediately after completion of the Auction.
7. The highest bidder accepted by the auctioneer will have to collect the items at their own cost within 20 days from the date of the auction against full payment of the auctioned value.
8. The auctioneer reserves the right to accept the bid on the spot or at any subsequent date. In case of dispute or problem with regard to the auction, the decision of the auctioneer will be final and binding.
9. The interested bidder shall be deemed to have inspected the items prior to the auction and the bid offered is at their own liberty and judgment. No complaints will be entertained and the decision of the Auction Committee shall be final and binding.
10. Applicable renewable/ownership transfer charges/fees shall be borne by the successful bidder.
11. All bidders are required to submit the bid along with a CID Copy with the proper postal address.
12. The decision of the Auction Committee to accept or reject the bid without assigning reason shall be final and binding.

INSTRUCTIONS TO THE BIDDERS

The Auction Bid shall be submitted in accordance with these instructions and bids not confirming to the instructions as under are liable to be rejected. These instructions shall form part of the bidding documents.

1. The bid should be submitted in **sealed envelope** superscripted as “**Bid for Unserviceable Items, Office Equipment, Lab and Production Equipment**”.
2. The Bid shall be accompanied by an Earnest Money Deposit (EMD) amounting to **Nu 10,000** (Ngultrum Ten Thousand).
3. If the sealed bids are found to have submitted without required EMD, the bidder shall be treated as disqualified.
4. The sealed envelope should be addressed to the **Chief Executive Officer, MSPCL** and submitted before the deadline i.e. 25th December 2023 at 2.30 PM.
5. The bid documents must be signed on each page by the bidder/authorized representative as a token of acceptance of the terms and conditions laid down in the tender document.
6. The bidder shall quote the best price for the selected item(s) as per the format attached as **Annexures**. The bid will be evaluated item wise.
7. The auction is on “**As is condition basis**” and the bidder(s) shall have to ascertain and get satisfied with the conditions of the auction items before the participation and no complaints shall be entertained after submitting the bid(s).
8. Bids shall be opened in the presence of the bidders/authorized representatives at 3.00 PM in the Conference of MSPCL.
9. The tender documents must be submitted in original and tender documents received through email, fax or photocopied shall not be accepted under any circumstances.

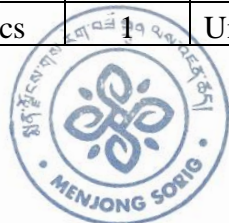

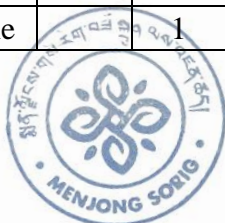
